Things to think about in your institution's approach to significance:

- Systematic vs. Unsystematic?
 - Systematic =
 - *clear purpose;*
 - clear and consistent written criteria, rigor, factual bases;
 - consistent and repeatable practices;
 - significance permeates all collections practices

• Deductive vs. Inductive?

- Deductive starts with the big ideas of the story and identifies what matters;
- Inductive focuses on lots of individual characteristics

Why "do" Significance?

- Better sustainability and public value
- Better collections
- Better presentations (i.e. exhibits, programming, interpretation)
- Better institutional profile and participation
- Better revenues and stakeholder support
- Better control of collections cost and resource use
